SALES ANNOUNCEMENT

The board of directors of Good Friend International Holdings Inc. (the “Company”, together with its subsidiaries, the “Group”) shares with the investors and shareholders of the Company the sales of the respective business of the Group for the eleven months ended 30 November 2015.

Sales of the respective business for the eleven months ended 30 November 2015

(1) CNC machine tools business

For the eleven months ended 30 November 2015, the Group sold to customers 1,467 units in respect of its CNC machine tools business (sales volume for the eleven months ended 30 November 2014: 1,921 units), amounting to approximately RMB618.328 million (for the eleven months ended 30 November 2014: approximately RMB882.849 million), representing a decrease of approximately 30% when compared to the same period in 2014.

(2) Parking Garage Structures business

For the eleven months ended 30 November 2015, the Group sold to customers 13,384 units in respect of its parking garage structures business (sales volume for the eleven months ended 30 November 2014: 11,625 units), amounting to approximately RMB199.135 million (for the eleven months ended 30 November 2014: approximately RMB175.438 million), representing an increase of approximately 14% when compared to the same period in 2014.

(3) Forklift trucks business

For the eleven months ended 30 November 2015, the Group sold to customers 1,395 units in respect of its forklift trucks business (sales volume for the eleven months ended 30 November 2014: 1,883 units), amounting to approximately RMB84.057 million (for the eleven months ended 30 November 2014: approximately RMB122.679 million), representing a decrease of approximately 31% when compared to the same period in 2014.

Accordingly, total sales to customers for the eleven months ended 30 November 2015 amounted to approximately RMB901.520 million, representing a decrease of approximately 24% when compared to the amount of approximately RMB1,180.966 million for the same period in 2014.
