SALES ANNOUNCEMENT

The board of directors of Good Friend International Holdings Inc. (the “Company”, together with its subsidiaries, the “Group”) shares with the investors and shareholders of the Company the sales of the respective business of the Group for the six months ended 30 June 2017.

Sales of the respective business for the six months ended 30 June 2017

(1) CNC machine tools business

For the six months ended 30 June 2017, the Group sold to customers 957 units in respect of its CNC machine tools business (sales volume for the six months ended 30 June 2016: 756 units), amounting to approximately RMB488.141 million (for the six months ended 30 June 2016: approximately RMB398.480 million), representing an increase of approximately 23% when compared to the same period in 2016.

(2) Parking Garage Structures business

For the six months ended 30 June 2017, the Group sold to customers 7,951 units in respect of its parking garage structures business (sales volume for the six months ended 30 June 2016: 7,502 units), amounting to approximately RMB105.401 million (for the six months ended 30 June 2016: approximately RMB96.210 million), representing an increase of approximately 10% when compared to the same period in 2016.

(3) Forklift trucks business

For the six months ended 30 June 2017, the Group sold to customers 837 units in respect of its forklift trucks business (sales volume for the six months ended 30 June 2016: 662 units), amounting to approximately RMB52.390 million (for the six months ended 30 June 2016: approximately RMB39.855 million), representing an increase of approximately 31% when compared to the same period in 2016.

Accordingly, total sales to customers for the six months ended 30 June 2017 amounted to approximately RMB645.932 million, representing an increase of approximately 21% when compared to the amount of approximately RMB534.545 million for the same period in 2016.
