**SALES ANNOUNCEMENT**

The board of directors of Good Friend International Holdings Inc. (the “Company”, together with its subsidiaries, the “Group”) shares with the investors and shareholders of the Company the sales of the respective business of the Group for the five months ended 31 May 2020.

Sales of the respective business for the five months ended 31 May 2020

(1) CNC machine tools business

For the five months ended 31 May 2020, the Group sold to customers 570 units in respect of its CNC machine tools business (sales volume for the five months ended 31 May 2019: 677 units), amounting to approximately RMB250.531 million (for the five months ended 31 May 2019: approximately RMB345.402 million), representing a decrease of approximately 27% when compared to the same period in 2019.

(2) Parking Garage Structures business

For the five months ended 31 May 2020, the Group sold to customers 2,316 units in respect of its parking garage structures business (sales volume for the five months ended 31 May 2019: 3,115 units), amounting to approximately RMB20.855 million (for the five months ended 31 May 2019: approximately RMB40.794 million), representing a decrease of approximately 49% when compared to the same period in 2019.

(3) Forklift trucks business

For the five months ended 31 May 2020, the Group sold to customers 106 units in respect of its forklift trucks business (sales volume for the five months ended 31 May 2019: 405 units), amounting to approximately RMB8.472 million (for the five months ended 31 May 2019: approximately RMB27.418 million), representing a decrease of approximately 69% when compared to the same period in 2019.

Accordingly, total sales to customers for the five months ended 31 May 2020 amounted to approximately RMB279.858 million, representing a decrease of approximately 32% when compared to the amount of approximately RMB413.614 million for the same period in 2019.
