ANNOUNCEMENT UNDER RULE 13.09(1) OF THE LISTING RULES

This announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The board of directors of Good Friend International Holdings Inc. (the “Company”) together with its subsidiaries (the “Group”) is pleased to share with the investors and shareholders of the Company the sales orders of the respective business of the Group for the three months ended 31 March 2012.

Sales orders of the respective business for the three months ended 31 March 2012

(1) CNC machine tools business

For the three months ended 31 March 2012, the Group received sales orders from customers of 546 units in respect of its CNC machine tools business (sales orders for the three months ended 31 March 2011: 1,646 units), amounting to approximately RMB318.866 million (including tax) (for the three months ended 31 March 2011: approximately RMB744.852 million (including tax)), representing a decrease of 57% when compared to the same period in 2011.

(2) Parking Garage Structures business

For the three months ended 31 March 2012, the Group received sales orders from customers of 2,232 units in respect of its parking garage structures business (sales orders for the three months ended 31 March 2011: 553 units), amounting to approximately RMB46.557 million (including tax) (for the three months ended 31 March 2011: approximately RMB10.167 million (including tax)), representing an increase of 358% when compared to the same period in 2011.

(3) Forklift trucks business

For the three months ended 31 March 2012, the Group received sales orders from customers of 918 units in respect of its forklift trucks business (sales orders for the three months ended 31 March 2011: 1,088 units), amounting to approximately RMB70.398 million (including tax) (for the three months ended 31 March 2011: approximately

RMB86.966 million (including tax)), representing a decrease of 19% when compared to the same period in 2011.

Accordingly, total sales orders received from customers for the three months ended 31 March 2012 amounted to approximately RMB435.821 million (including tax), representing a decrease of 48% when compared to the amount of approximately RMB841.985 million (including tax) for the same period in 2011.
