ANNOUNCEMENT UNDER RULE 13.09(1) OF THE LISTING RULES

This announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The board of directors of Good Friend International Holdings Inc. (the “Company”) together with its subsidiaries (the “Group”) is pleased to share with the investors and shareholders of the Company the sales of the respective business of the Group for the ten months ended 31 October 2012.

Sales of the respective business for the ten months ended 31 October 2012

(1) CNC machine tools business

For the ten months ended 31 October 2012, the Group sold to customers 1,962 units in respect of its CNC machine tools business (sales volume for the ten months ended 31 October 2011: 3,081 units), amounting to approximately RMB989.036 million (for the ten months ended 31 October 2011: approximately RMB1,286.957 million), representing a decrease of 23% when compared to the same period in 2011.

(2) Parking Garage Structures business

For the ten months ended 31 October 2012, the Group sold to customers 8,329 units in respect of its parking garage structures business (sales volume for the ten months ended 31 October 2011: 5,983 units), amounting to approximately RMB135.610 million (for the ten months ended 31 October 2011: approximately RMB90.528 million), representing an increase of 50% when compared to the same period in 2011.

(3) Forklift trucks business

For the ten months ended 31 October 2012, the Group sold to customers 2,214 units in respect of its forklift trucks business (sales volume for the ten months ended 31 October 2011: 3,724 units), amounting to approximately RMB138.552 million (for the ten months ended 31 October 2011: approximately RMB233.360 million), representing a decrease of 41% when compared to the same period in 2011.

Accordingly, total sales to customers for the ten months ended 31 October 2012 amounted to approximately RMB1,263.198 million, representing a decrease of 22% when compared to the amount of approximately RMB1,610.845 million for the same period in 2011.
