ANNOUNCEMENT UNDER RULE 13.09(1) OF THE LISTING RULES

This announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The board of directors of Good Friend International Holdings Inc. (the “Company”) together with its subsidiaries (the “Group”) is pleased to share with the investors and shareholders of the Company the sales orders of the respective business of the Group for the one month ended 31 January 2011.

Sales orders of the respective business for the one month ended 31 January 2011

(1) CNC machine tools business

For the one month ended 31 January 2011, the Group received sales orders from customers of 621 units in respect of its CNC machine tools business (sales orders for the one month ended 31 January 2010: 427 units), amounting to approximately RMB287.102 million (including tax) (for the one month ended 31 January 2010: approximately RMB 230.953 million (including tax)), representing an increase of 24% when compared to the same period in 2010.

(2) Parking Garage Structures business

For the one month ended 31 January 2011, the Group received sales orders from customers of 190 units in respect of its parking garage structures business (sales orders for the one month ended 31 January 2010: 836 units), amounting to approximately RMB 3.708 million (including tax) (for the one month ended 31 January 2010: approximately RMB 12.643 million (including tax)), representing a decrease of 71% when compared to the same period in 2010.

(3) Forklift trucks business

For the one month ended 31 January 2011, the Group received sales orders from customers of 301 units in respect of its forklift trucks business (sales orders for the one month ended 31 January 2010: 137 units), amounting to approximately RMB 24.823 million (including tax) (for the one month ended 31 January 2010: approximately RMB 13.17 million

(including tax)), representing an increase of 88% when compared to the same period in 2010.

Accordingly, the total sales orders received from customers for the one month ended 31 January 2011 amounted to approximately RMB 315.633 million (including tax), representing an increase of 23% when compared to the amount of approximately RMB 256.766 million (including tax) for the same period in 2010.
