SALES ANNOUNCEMENT

The board of directors of Good Friend International Holdings Inc. (the “Company”, together with its subsidiaries, the “Group”) shares with the investors and shareholders of the Company the sales of the respective business of the Group for the three months ended 31 March 2019.

Sales of the respective business for the three months ended 31 March 2019

(1) CNC machine tools business

For the three months ended 31 March 2019, the Group sold to customers 398 units in respect of its CNC machine tools business (sales volume for the three months ended 31 March 2018: 450 units), amounting to approximately RMB170.174 million (for the three months ended 31 March 2018: approximately RMB213.828 million), representing a decrease of approximately 20% when compared to the same period in 2018.

(2) Parking Garage Structures business

For the three months ended 31 March 2019, the Group sold to customers 1,471 units in respect of its parking garage structures business (sales volume for the three months ended 31 March 2018: 1,645 units), amounting to approximately RMB23.533 million (for the three months ended 31 March 2018: approximately RMB20.556 million), representing an increase of approximately 14% when compared to the same period in 2018.

(3) Forklift trucks business

For the three months ended 31 March 2019, the Group sold to customers 182 units in respect of its forklift trucks business (sales volume for the three months ended 31 March 2018: 209 units), amounting to approximately RMB12.064 million (for the three months ended 31 March 2018: approximately RMB14.449 million), representing a decrease of approximately 17% when compared to the same period in 2018.

Accordingly, total sales to customers for the three months ended 31 March 2019 amounted to approximately RMB205.771 million, representing a decrease of approximately 17% when compared to the amount of approximately RMB248.833 million for the same period in 2018.
