SALES ANNOUNCEMENT

The board of directors of Good Friend International Holdings Inc. (the “Company”, together with its subsidiaries, the “Group”) shares with the investors and shareholders of the Company the sales of the respective business of the Group for the seven months ended 31 July 2018.

Sales of the respective business for the seven months ended 31 July 2018

(1) CNC machine tools business

For the seven months ended 31 July 2018, the Group sold to customers 1,165 units in respect of its CNC machine tools business (sales volume for the seven months ended 31 July 2017: 1,107 units), amounting to approximately RMB550.980 million (for the seven months ended 31 July 2017: approximately RMB582.318 million), representing a decrease of approximately 5% when compared to the same period in 2017.

(2) Parking Garage Structures business

For the seven months ended 31 July 2018, the Group sold to customers 6,012 units in respect of its parking garage structures business (sales volume for the seven months ended 31 July 2017: 8,970 units), amounting to approximately RMB79.820 million (for the seven months ended 31 July 2017: approximately RMB122.490 million), representing a decrease of approximately 35% when compared to the same period in 2017.

(3) Forklift trucks business

For the seven months ended 31 July 2018, the Group sold to customers 556 units in respect of its forklift trucks business (sales volume for the seven months ended 31 July 2017: 937 units), amounting to approximately RMB39.197 million (for the seven months ended 31 July 2017: approximately RMB60.150 million), representing a decrease of approximately 35% when compared to the same period in 2017.

Accordingly, total sales to customers for the seven months ended 31 July 2018 amounted to approximately RMB669.997 million, representing a decrease of approximately 12% when compared to the amount of approximately RMB764.958 million for the same period in 2017.
