**ANNOUNCEMENT UNDER RULE 13.09(1) OF THE LISTING RULES**

This announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The board of directors of Good Friend International Holdings Inc. (the “Company”) together with its subsidiaries (the “Group”) is pleased to share with the investors and shareholders of the Company’s sales of the respective business of the Group for the eight months ended 31 August 2011.

**Sales of the respective business for the eight months ended 31 August 2011**

(1) CNC machine tools business

For the eight months ended 31 August 2011, the Group sold to customers 2,490 units in respect of its CNC machine tools business (sales volume for the eight months ended 31 August 2010: 1,569 units), amounting to approximately RMB 1,029.884 million (for the eight months ended 31 August 2010: approximately RMB 666.072 million), representing an increase of 55% when compared to the same period in 2010.

(2) Parking Garage Structures business

For the eight months ended 31 August 2011, the Group sold to customers 4,157 units in respect of its parking garage structures business (sales volume for the eight months ended 31 August 2010: 4,270 units), amounting to approximately RMB 61.741 million (for the eight months ended 31 August 2010: approximately RMB 65.941 million), representing a decrease of 6% when compared to the same period in 2010.

(3) Forklift trucks business

For the eight months ended 31 August 2011, the Group sold to customers 3,055 units in respect of its forklift trucks business (sales volume for the eight months ended 31 August 2010: 1,305 units), amounting to approximately RMB 189.275 million (for the eight months ended 31 August 2010: approximately RMB 87.906 million), representing an increase of 115% when compared to the same period in 2010.

Accordingly, total sales to customers for the eight months ended 31 August 2011 amounted to approximately RMB 1,280.900 million, representing an increase of 56% when compared to the amount of approximately RMB 819.919 million for the same period in 2010.
