ANNOUNCEMENT UNDER RULE 13.09(1) OF THE LISTING RULES

This announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The board of directors of Good Friend International Holdings Inc. (the “Company”) together with its subsidiaries (the “Group”) is pleased to share with the investors and shareholders of the Company the sales of the respective business of the Group for the nine months ended 30 September 2012.

Sales of the respective business for the nine months ended 30 September 2012

(1) CNC machine tools business

For the nine months ended 30 September 2012, the Group sold to customers 1,805 units in respect of its CNC machine tools business (sales volume for the nine months ended 30 September 2011: 2,808 units), amounting to approximately RMB910.397 million (for the nine months ended 30 September 2011: approximately RMB1,172.055 million), representing a decrease of 22% when compared to the same period in 2011.

(2) Parking Garage Structures business

For the nine months ended 30 September 2012, the Group sold to customers 6,812 units in respect of its parking garage structures business (sales volume for the nine months ended 30 September 2011: 4,832 units), amounting to approximately RMB110.076 million (for the nine months ended 30 September 2011: approximately RMB71.125 million), representing an increase of 55% when compared to the same period in 2011.

(3) Forklift trucks business

For the nine months ended 30 September 2012, the Group sold to customers 2,087 units in respect of its forklift trucks business (sales volume for the nine months ended 30 September 2011: 3,406 units), amounting to approximately RMB129.841 million (for the nine months ended 30 September 2011: approximately RMB212.745 million), representing a decrease of 39% when compared to the same period in 2011.

Accordingly, total sales to customers for the nine months ended 30 September 2012 amounted to approximately RMB1,150.314 million, representing a decrease of 21% when compared to the amount of approximately RMB1,455.925 million for the same period in 2011.
