SALES ANNOUNCEMENT

The board of directors of Good Friend International Holdings Inc. (the “Company”, together with its subsidiaries, the “Group”) shares with the investors and shareholders of the Company the sales of the respective business of the Group for the eleven months ended 30 November 2018.

Sales of the respective business for the eleven months ended 30 November 2018

(1) CNC machine tools business

For the eleven months ended 30 November 2018, the Group sold to customers 1,838 units in respect of its CNC machine tools business (sales volume for the eleven months ended 30 November 2017: 1,900 units), amounting to approximately RMB905.517 million (for the eleven months ended 30 November 2017: approximately RMB915.450 million), representing a decrease of approximately 1% when compared to the same period in 2017.

(2) Parking Garage Structures business

For the eleven months ended 30 November 2018, the Group sold to customers 10,067 units in respect of its parking garage structures business (sales volume for the eleven months ended 30 November 2017: 12,919 units), amounting to approximately RMB125.308 million (for the eleven months ended 30 November 2017: approximately RMB175.084 million), representing a decrease of approximately 28% when compared to the same period in 2017.

(3) Forklift trucks business

For the eleven months ended 30 November 2018, the Group sold to customers 908 units in respect of its forklift trucks business (sales volume for the eleven months ended 30 November 2017: 1,494 units), amounting to approximately RMB65.026 million (for the eleven months ended 30 November 2017: approximately RMB94.213 million), representing a decrease of approximately 31% when compared to the same period in 2017.

Accordingly, total sales to customers for the eleven months ended 30 November 2018 amounted to approximately RMB1,095.851 million, representing a decrease of approximately 8% when compared to the amount of approximately RMB1,184.747 million for the same period in 2017.
